1. The Clerk explained that she had received a letter of resignation from the Chairman, Peter Parker.

As a result, we welcomed the Vice Chairman Arwel Pierce to lead the Agenda

2. The Vice-Chairman thanked him for his work as Chairman albeit this was for a short time.

3. The members extended condolences to Richard Evans, who lost his father recently. Best wishes were sent to Lynda, wife of Simon Jones, for a speedy recovery following an accident that occurred outside their home.

4. As no one had applied for the post of Clerk of the Council, the Chairman explained the need to sustain the continuity of Council work

Noted: the deadline for the post of Clerk has been extended until 31.10.15 Therefore, the above appointments can be considered as temporary, and if no one applies, they will remain in place until 03/31/16. The Clerk agreed to accept all letters etc and to distribute as required.

5. The Chairman expressed sincere thanks to Eileen Jones for her thorough and conscientious work as Clerk for over 21 years. The councillors greatly appreciated her decision to stay on until this meeting in order to facilitate a temporary management framework amongst the members

6. i. The minutes of July 15 were dully accepted and signed.

6. ii Matters arising:

- Need to change item 7 to read *Clive* Jones instead *Kevin* Jones.
- Cllr. Bethan Lawton had made enquiries regarding the responsibilities of maintaining the Graig. Parts have been registered - others have not. BL to contact for more reassurance and confirmation.

7. **Playground;** report A.H.Jones.

- Boundaries and the Pavilion in good order. It was agreed to proceed with all that's necessary to fix the swings small (BL and AHJ)

small seats £ 115 + VAT; 8 Shackle@ £ 3.30 + VAT; 8 cap @ 25p,

4x chain @ £ 30.88 + VAT.

• testing the plug: Uncertainty as to whether Gareth Roberts had been to carry out the test.
• Agreed to pay - Playsafety Ltd. £ 78 (Cheque 461); Water Board £ 219.53 (Cheque 462); Refund the Clerk £ 110 - Electricity April to Sept.'15 + £ 6.99 for a kettl(£116. 99 Cheque 456).

8. **Paths:** Path behind Dolithel and Factory requires attention. Need to contact Liz Haynes

9. **Councillor B. Lawton's Report:** attention was drawn to the 'Her Gwynedd Magazine' noting especially Gwynedd Council's plans to meet the challenge of the cuts. Everyone was encouraged to participate in the negotiations.
10. **Maintenance within the village:** repairs to the Millennium Bench. AHJ to contact Kevin Jones with a view either to buy a new bench or repair the existing one. Bramble clearance is desperately needed.
11. **Public Toilets:** A letter was received from Gwynedd Council stating that the cost of keeping the toilets open over winter would be £ 1,780 + VAT.
It was unanimously decided that this amount was too high and the proposal was rejected. Gwynedd Council to be approached to install new signs on the doors and to provide a constant supply of paper towels and waste bins.
It was noted that the Cynefin Group will not be offering a grant towards their cost.
12. **Planning Application:** to build a toilet block at Ynysmaengwyn Caravan Park
Agreed with the application in accordance with the decision of the Site Committee 08/09/15.
13. **One Voice Wales:** Dates of meetings were noted
14. **Job advert for Clerk:** Agreed to pay Cambrian News - £ 119.04. (Cheque 465)
15. **Application to the Community Centre Committee:** The decision of the Site Committee (09.08.15) to pay £ 50 rent to the Ganolfan for the use of a storage shed to house Council's property following the Clerk's retirement was confirmed. This to be paid in advance from 01.10.15.
