Correspondence

- Mrs Eileen Jones warmly thanked the Council for its support during her tenure of 21 years as Clerk of the Council
- Advertising the post of Clerk
AP reported that he had been in contact with One Voice Wales regarding the appointment of a temporary Clerk and Financial Officer due to the lack of applicants. **It was agreed that a meeting of the Council be held on Tuesday November 10th at 5.30 to revisit the content of the advert should the response prove negative again.**

Maintaining the Graig

It appears that neither Gwynedd C.C nor the Housing Association is willing to undertake this responsibility. BL promised to make further enquiries.

Playground.

- AHJ reported that the general condition of the field appears to be satisfactory.
- It was agreed for BL to order the required number of swings at a cost of £373 + vat + £16 carriage
- Several complaints had been received regarding the rubbish thrown around the children's play area.
- Bonfire night. - Members supported the application made by the Ganolfan Committee to hold the annual event. No hiring charge will be implemented but the Committee was requested to provide details of its arrangements to lock the main gate and clearing the field after the event.

Millennium Notice Board.

Being that the estimate provided appeared to be high, it was resolved that it would be more prudent to replace some of the laths and use the present bench as replacement. Further staining work will be required. AHJ was thanked for clearing the brambles.

Paths

Liz Haynes of GCC had confirmed by letter that the Authority would be responsible for the maintenance work on the paths by the Factory and Dolithel and resurfacing the pavements at Maesygrug and Dolithel.

Cllr B Lawton report.

Confirmed that the work of clearing parts of the village is in hand.
