- Position of Clerk;

RAP explained that he had contacted Tywyn Town Council's Clerk – we need to await his reaction. After discussions it was decided to advertise the post again in the Cambrian News, on the Website, and on the notice board. Closing date - 12.05.16. Need to delete the reference to bilingualism.

- Football club:

BL has received a check for £ 400.

AHJ has noticed that some of the poles that run parallel to the pitch are rotten. Clerk to contact the Chairman of the Club to ask them to replace as required.

- Entrance on Tynllwyn Road:

A letter was read from the National Park stating that they would monitor the situation.

- Cycle Track:

In his letter Adrian Williams states that Gwynedd Council will see to the wall for this year only but hereafter the Council will need to contact the owner.
