Minutes of the meeting held on Monday 21st December 2015 at 7pm

A warm welcome was extended by the Chairman.

1. Minutes of November 16th were read and accepted as a true record by Coun. B. Lawton; seconded by Ieu Thomas

2. **Matters arising:**

- a) Position Clerk: so far, no one has applied. It was agreed to wait until late January to see what would be the response before discussing the matter with another Clerk from within the catchment area. The advertisement will appear in the Cambrian News and on the village notice board before the end of the year.
- b) Flower pots: unable to carry out the work due to inclement weather
- c) Roof above Pavilion - work attended to by AHJ.
Guttering will need attention in the immediate future
- d) New Lock: in hand
- e) Charles Mumford had addressed the bad odour in the Pavilion sink
- f) Concrete pole set in concrete to hold the boundary rope has become loose
- g) Noticeboard : To receive attention when the weather improves.
- h) The report by RAP of the One Voice Wales meeting held in Dolgellau at the end of November
 - Gwynedd Community Housing representative presented a report on the work of the Agency
 - The proposed intention by Gwynedd Council of charging £150 to replenish the salt in the bins or £281 to place a new bin and refilling once only had created much difficulties within the Community Councils This was not applicable to Brynchrug Council as no bins have been installed in the area.
 - There was a lengthy discussion following the decision of CC Cynwyd to contact their constituents in Welsh only. Following this, the Clerk was instructed to ensure that:
 - i. a bilingual notice of all meetings of the Council be placed on the notice board
 - ii. remind voters that a copy of the minutes are available on the web or by contacting the Clerk

3. **Report by County Councillor B Lawton.**

- Attended a National Park meeting at Aberdyfi – representations by other Community Councillors within the area was poor.
- 2,800 constituents had responded to the Gwynedd Questionnaire.
- Gwynedd Council has received a very favourable report by the Welsh Government Audit Panel.
- Final settlement of the Assembly to Gwynedd is 1.7%
