Before starting work on the formal Council meeting the Chairman welcomed five members of the public to discuss and explore the idea of forming a Neighbourhood Watch in the community.

He also welcomed Ms Kath Lake –Buller, area PCSO, to lead the discussion.

It was decided to support the need and asked members of the public present to take care of organizing a Public Meeting in the village with the AHJ, Chairman, in charge of the activity.

1. Declaration of interest: None

2. Minutes of January 18th were accepted. (IT / PP)

3. Matters arising:

a) Advertising post of Clerk. An advertisement appeared in Y Dydd but so far no one has shown interest.

AHJ to contact the Clerk of Tywyn Town Council to ascertain whether he would be interested in the work.

IT expressed his view that the work of BL and RAP in maintaining the Council's work temporarily should be acknowledged in some way.

b) Cutting the grass in the Cae Chwarae: It was explained that due to a misunderstanding, Gwynedd Council had revised their first tender.

It was decided to offer the work to J.K.Jones Landscapers Machynlleth.

Cutting 11 times a year - £ 800 + VAT

c) Supervision of the Bont area by the local Police: Clerk had spoken with PCSO Meirion Jones.

4. County Councillor's Report: - Gwynedd Council financial cuts to be discussed by the Cabinet soon, followed by a final decision by the full Council.

An invitation was also received by Gwynedd Council for Community Council members to meet its representatives to discuss the financial challenges ahead. Meeting to be held at Ysgol Uwchradd Tywyn between 6-8pm on 10/03/16. All members were asked to make every effort to attend.
