7. Financial Matters:

- a. Financial Report June 2024 This was agreed as a true account and approved.

- b. Payments Payments in : T&BFC Payments out. Gwynedd Council, Geldards Solicitors, Playsafety and Clerks pay.
- c. 2023/24 Audit Cashbook, Expenses and Income sheets, Annual Return, Variances and other audit documentation agreed and signed by AJ & Clerk. This will now be submitted to Gwynedd Council
- d. IRPW paperwork New forms signed by those Councillors who both accepted and opted out of the annual payment. This is now ready for submission.

Asset Register reviewed and the two bus shelters which the Council had inherited were added by hand. All other assets listed were correct and approved. 8. Representatives' Reports:

- Alan Jones Cae Chwarae/Playing Field AJ confirmed that there were no other issues save for those discussed earlier in the meeting relating to the ROSPA report.
- 9. County Councillors Report: None

10. Any Other Business:

- Training AJ advised the Council of the Playpark Inspectors Course which he was interested in
 attending. JJ explained that she had been in contact with Chirk Council who were organising the
 course but was still waiting for confirmation of dates. They had said they expected the cost to be
 £100 and you could either purchase a Certificate of Attendance (£10) or sit the exam which is likely
 to be an additional £150 cost.
- Grass Cutting on Rock Terrace Jones & Jones have refused to cut the grass here due to
 considerable amount of dog fouling. It was suggested that JJ write to ADRA and advise that unless
 their tenants keep this area clean then the only option is to spray the grass and for this additional
 work, we would be looking for recompense from them for the cost.
- Footpath Maintenance JJ to contact and advise that the footpath leading from Pont Fathew in a westerly direction towards the Dysynni, needs attention, this is a floodbank and is currently very overgrown. It is an asset of theirs and needs to be maintained as it has been previously.
- Abandoned Vehicles JJ advised that she had been contacted by a person within the village who
 was concerned about two vehicles which it is believed have been abandoned by the public toilets.
 JJ advised of advice given, and that it had been followed and Gwynedd Council were now involved.
 No further action required at this time.
- B4405 It has been brought to the attention of the Council that despite four road closures the road crossing collapse at Rhosgadlas (Dolffanog) has still not been repaired. JJ asked to contact Adrian at the Highways Department.
