

**Minutes of Bryncreg Community Council held at Y Ganolfan Bryncreg, Wednesday 15<sup>th</sup> of July 2015 at 7p.m.**

1. Apologies: Vice Chair Arwel Pierce (Holiday), Ieu Thomas (holiday), George Evans (emergency at home)

2. Declaration of Interest: None

3. All were welcomed by the Chair.

4. June Minutes were received but for number 15, add – after a proposal of £100 – to be capped at that amount.

The minutes were signed by the Chair.

5. Playing Field: Report by Alan Jones – the Football Club are using the small goals and have moved them to

the centre of field. It was passed to Pay Cwmni Tân Llyn and to reimburse the Clerk for electricity and the

kettle (6.99).

7. Report by Gwynedd Councillor Beth Lawton: It was noted that the advisory meeting regarding Gwynedd cuts

in September should be attended by all to fight the proposed cuts. The Rock – Beth had spoken to Kevin Jones,

and was told that it was not the responsibility of Gwynedd Council, but Gwynedd Community Homes. Nothing

had been registered with the Land Registry. Craig Y Deryn School is full – need to complain to the

admissions officer as there is no room for new children within the catchment area. Tywyn Hospital has a State

of the Art X ray unit.

9. Public Toilets: To enquire for the cost of keeping them open over the Winter months. An application for a

were sympathetic with Mrs Anikey and could see how this caused anxiety. It was felt that there was enough

room opposite the applicants house to build a shed. The Councillors present decided to support Mrs Anikey.

a building for Biomass boiler and workshop within the registered building Grade 11\*. – it was discussed

and passed to support the improvement.
